**NOTICE IS HEREBY GIVEN** that the City of Sammamish received an application for a reasonable use exception (RUE) on September 25, 2018, for the development of a single-family residence on a lot within the R-4 zoning district encumbered by critical areas and their associated buffers. The subject property contains steep slopes and is located within the erosion hazard area and within the landslide hazard area. The critical areas, when combined with the required buffers and tree retention requirements, provides little developable area for the construction of a single-family residence.

In accordance with SMC 20.05.060, on October 30, 2018 the City issued this Notice of Application by the following means: mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and by placing a legal notice in the local newspaper.
