**PROJECT DESCRIPTION:** Scott Fletcher submitted a request for interpretation regarding whether Public Works Standards Section 7.8.H.1 applies to his project PSHP2023-00345, so as to exempt him from having to construct the required frontage improvements along the full length of the project site adjacent to the public right-of-way. On February 21, 2025, the Public Works Director issued an interpretation concluding that PW Standards Section 7.8.H.1 does not apply to exempt Mr. Fletcher's development project from construction frontage improvements because the development project is to subdivide one lot into two lots, not to build or remodel a single family home on a single residential lot. On March 11, 2025, Mr. Fletcher filed an appeal of the PW Standards interpretation.
