WHEREAS, to provide City services and infrastructure in the most efficient and costeffective manner, the City of Sammamish should communicate its priorities and interests to state legislators and other interested parties; and

WHEREAS, the legislative priorities attached to this Resolution reflect the needs and interests of the residents and businesses in the Sammamish community.

# NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SAMMAMISH, WASHINGTON, RESOLVES AS FOLLOWS:

The 2024 City of Sammamish Legislative Priorities attached to this Resolution are hereby adopted. The City Manager shall provide these priorities to legislators in Legislative Districts 5, 41 and 45 prior to the start of the 2024 session and to other interested parties upon request.

# **2024 Legislative Agenda** City of Sammamish

# Funding for Endeavour Elementary School Safe Route and Flood Reduction Project Cost: \$7.1M | Request: \$1M

Endeavour Elementary School is located along a section of Issaquah-Fall City Road that floods during heavy rains. Flooding events have closed the road for weeks at a time, impacting access to the school, community safety, emergency response times, and causing road degradation. This project will raise the roadway approximately three feet at the low point, widen to three lanes, and install bike lanes, curb, gutter and sidewalk to create a safe access route to the school.



# Support Progressive and Realistic City Revenue Options

Local government revenues are not keeping pace with the rising cost of delivering services, and existing revenue options available to cities unfairly penalize lower income community members.

## Enact progressive revenue options

Support efforts to revise tax structures to provide progressive revenue options for cities.

#### Revise the arbitrary 1% property tax cap

Revise the arbitrary 1% property tax cap so that it tracks inflation, with a new cap not to exceed 3%. This change will help the City keep pace with the rapidly rising cost of providing essential services, ensuring our community is financially sustainable into the future.

## **Support Local Climate Action Initiatives**

Local jurisdictions are a key partner in helping Washington achieve its commitment to reduce greenhouse gas emissions by 95% by 2050.

#### **Climate Commitment Act funding**

Improve access to Climate Commitment Act funding, including direct distributions, for city priorities that support carbon reduction and climate resiliency, such as electrification grants.

#### Reduce wasteful packaging

Support proposals to establish producer responsibility for packaging, such as the WRAP Act.

#### Affordable Housing

- **Funding for Affordable Housing:** Sammamish supports new and flexible funding options for local jurisdictions that address the need for affordable housing, such as a local option Real Estate Excise Tax (REET). Such options should be progressively structured to best meet the needs of low and moderate income households.
- Affordable Housing Near Fixed Route Transit: Affordable housing should be required in future planning for growth near fixed route transit. Sammamish supports setting affordability goals for transit-oriented development, and providing local flexibility and planning resources to help communities achieve those goals.

#### **Multimodal Transportation Improvements**

Continue to appropriately use Climate Commitment Act funding in the transportation budget to support improved transit service, pedestrian and bike safety initiatives, e-bike rebates, electrification infrastructure, and similar investments.

#### Access to Behavioral Health Resources

The City recognizes that many in our community are struggling with behavioral health challenges, including our youth. Therefore, the City supports greater access to the entire continuum of behavioral health services and substance use disorder (SUD) treatment for adults and youth.

#### Full Funding for Washington Public Schools

Ensure every school has the resources it needs to provide engaging learning opportunities.
