Notice is hereby given that the City of Sammamish Planning Commission will hold a Public Hearing regarding the Sammamish Transportation Master Plan.

**SUMMARY OF PROPOSAL:** The City of Sammamish's first Transportation Master Plan (TMP) will shape the city for years to come by providing a strategic framework that will guide transportation decisions and investments for the next 20 years in support of the long-term vision for the city. The goals and policies in the Transportation Element of the City's Comprehensive Plan Update serve as the foundation for the TMP. The TMP will be adopted by reference into Volume 2 of the City's Comprehensive Plan Transportation Element and will provide the framework for developing a multi-modal transportation network that will enhance greater connectivity within the city and to the region.

**HEARING SCHEDULE:** Public testimony will be taken by the Planning Commission on August 29, 2024, at a public hearing. The Public Hearing will be part of a Planning Commission Special Meeting, which will start at 6:30 pm on August 29, 2024, at Sammamish City Hall.
