

**APPEAL PERIOD:** March 24, 2025, to April 14, 2025, until 5:00 p.m.

**NOTICE IS HERBY GIVEN** that on March 24, 2025, <u>APPROVAL</u> was granted by the Department of Community Development for the North Lake Sammamish Lift Station, PAUE2024-00955. The project includes installation of a new pump pit to house two new 300 HP, 2,000 gpm capacity pumps. The pit will be large enough to



accommodate a third pump in the future if required. The project will also include construction of a building to house a 300 kW standby generator, remodel of the existing electrical building to house new electrical equipment, and a new odor control building. The existing dry pit will be converted to additional sewer wet well storage to increase capacity. In addition, the project will include new 6-foot site fencing with vinyl slats to provide screening from the neighborhood.
