**NOTICE IS HEREBY GIVEN** that on June 12, 2024, <u>APPROVAL</u> was granted by the Department of Public Works for the Liu Property Drainage Adjustment. Public notice has been provided via mailed notice to property owners within 1,000 feet of the subject site, a sign posted on the subject site, and publication of a legal notice in the local newspaper.

**PROJECT DESCRIPTION:** The applicant requested an exemption from SMC 21.03.050.D.4.e, which eliminates an exemption from core requirement #3 (Flow Control) for projects located in a critical drainage area. The drainage adjustment request is to allow the standard exemption from core requirement 3.
