**SUMMARY OF AMENDMENTS:** The City is required by state law (RCW 35.77.010) to adopt a TIP that covers the ensuing six years of planned transportation improvements and to update it annually. These updates must be pursuant to one or more public hearings, be consistent with the City's Comprehensive Plan and be adopted by July 1st of each year.
